SECTION B: COMMUNITY DEMOGRAPHIC INFORMATION

Factors expected to contribute to the growth or decline of your parish/community's population and economy.

We had problems in 2015 that lead our minister to leave parish ministry and caused a division in our church. We have since had an interim minister for 2 years, solo minister for 3 years and a bridge minister for 1.5 years. Since 2015 we saw a 62% decrease in membership and a 18% decrease in non-designated total receipts in 2021, including a \$30,102 PP forgiven loans in 2020 and 2021 and 60,000 in special gifts to support the budget. Our undesignated assets have grown from \$130,285 to \$168,000. In 2020 we formed a team to develop a Strategic Plan that the session is responsible for implementing. We called a strong minister who we are excited to work with to better use our membership assets and reach out to our community to draw them to a strong Christian faith.
