ACKNOWLEDGMENT OF LAND

The Rev. David Baer, the Stated Clerk, acknowledged the Lenape people, the original inhabitants of the land where he makes his home, in northern New Jersey, whose territory also stretched eastward into the bounds of PSNE in present-day Greenwich and Stamford. He gave a brief historical account, followed by information about the retrocession of a property held by the Presbytery of Hudson River in Stony Point, New York, to the Ramapough Lenape Nation. Mr. Baer led the assembly in a prayer, "For Just Work," from the PC(U.S.A.) *Book of Common Worship*.

CONSENT MOTION

The Presbytery **VOTED**:

- That the Presbytery grant excuses from attendance at the 184th Stated Meeting to those needing the same, but that the Presbytery suspend the reading of their names.
- That the Presbytery grant excuses for early departures from the 184th Stated Meeting for those requesting the same by *notifying the clerk in a timely manner by any means practicable*, but that the Presbytery suspend the reading of their names.
- That the Presbytery seat as Corresponding Members those ministers for whom a request is made at the beginning of the meeting.
- That the Presbytery approve the minutes of the 183rd Stated Meeting held on November 18, 2020, as provided with the materials for this meeting (action item #1 in the Clerk's Report).
- That the Presbytery spread upon the minutes the report of the Treasurer (marked Ref. C, with numbered attachments, in the materials for this meeting).

GREETINGS FROM SPRINGFIELD: MLK

The Rev. Dr. Terrlyn Curry Avery, pastor of the Martin Luther King, Jr. Community Presbyterian Church in Springfield, Massachusetts, brought greetings from that congregation, which suffered a fire by arson in December. Dr. Avery spoke of the pain of seeing the destruction caused by the fire, and she thanked the assembly for the many expressions of support they have received, as well as financial contributions for the rebuilding of the church building. A suspect is in custody, and has been charged with three prior attempts to set fire to the building, but not yet with causing the final

and most destructive fire. The Rev. Shannan Vance-Ocampo led the assembly in prayer for the MLK Church

WORSHIP

The Rev. Julie Emery called the assembly to worship with a time of silence a poem, "Until that Day," and a prayer. The Rev. Shannan Vance-Ocampo, the Rev. Deborah Packard, and the Rev. Melodie Long led portions of the service of worship.

READING OF THE DECISION AND CONSENT ORDER OF THE PERMANENT JUDICIAL COMMISSION

At the recommendation of the Stated Clerk, and upon a motion properly made and seconded, the Presbytery **VOTED** to go into **EXECUTIVE SESSION** for the reading of a Decision and Consent Order of the Permanent Judicial Commission. (The Decision and Consent Order is the final resolution to a disciplinary matter involving a member of the First Presbyterian Church of Greenwich. The Presbytery agreed, on November 16, 2019, to assume original jurisdiction from the Session of that church for the specific and limited purpose of investigation and, if necessary, trial of the matter.)

Upon a motion properly made and seconded, the Presbytery **VOTED**:

- to COME OUT of executive session, and
- that the full Decision and Consent Order of the Permanent Judicial Commission be **ENTERED** upon the Minutes of the Presbytery, and
- that the clerk be **INSTRUCTED** to redact the name of the accused from the Minutes that are provided on the Presbytery's web site.

Arrival Statement

This disciplinary case comes before the Permanent Judicial Commission (PPJC or this Commission) of the Presbytery of Southern New England (PSNE or Presbytery) after action by the Presbytery, on November 16, 2019, to assume Original Jurisdiction of this matter from the Session of the First Presbyterian Church of Greenwich, Connecticut, (FPC Greenwich) at their request, based on allegations of violations of *Book of Order* sections W-4.0404g (failing to further the peace, unity and purity of the church.) and W-4.0404i (failing to be a faithful ruling elder, watching over the people, providing for their worship, nurture, and service.) by Ruling Elder, Lisa Baker and Teaching Elders, Susan Pfeil and John Sandel (Accusers) against Ruling Elder and member of First Presbyterian Church of Greenwich, Connecticut,

The matter now before this Commission is to adjudicate a proposed Alternative Form of Resolution (AFR) between the Accused and the Investigating Committee (IC) as a possible means to bring this matter to a close.

Jurisdictional Statement

This Commission finds, by virtue of the action of the Presbytery in assuming Original Jurisdiction of this matter, that it has jurisdiction to render a Decision on the proposed AFR.

History

On November 13, 2019, the Clerk of the Session of FPC Greenwich received from the Accusers A Statement of Offense, (PCUSA Form 26) alleging that the Accused had violated W-4.0404g & i by, "engag[ing] in an extramarital affair with the Rev. Sean Miller," who was at the time the installed pastor of FPC Greenwich, and by, "attempting to misrepresent the complaint against Rev. Miller among other members of the Session [of FPC Greenwich]."

After that date, the Session of FPC Greenwich requested that the Presbytery assume original jurisdiction of this disciplinary matter. On November 16, 2019, at its stated meeting, the Presbytery acted to assume original jurisdiction of this matter from the Session of FPC Greenwich and authorized the IC already empaneled in a related Disciplinary matter to also investigate and bring to resolution this matter.

The IC, after performing a thorough inquiry, entered into conversation with the Accused in pursuit of an AFR, as provided for in the Rules of Discipline (D-10.0202(j)). On, February 18, 2020, the IC, drafted a Document titled, *Investigative Committee Recommended Actions* which, after being signed by each member of the IC, was forwarded to the Accused for her agreement and signature.

On November 16, 2020, after an almost eight-month gap in communication between the IC and the Accused, the IC electronically forwarded to the Stated Clerk of PSNE, PCUSA Form 34, formally charging the Accused with violating W-4.0404g, "in that, pursuing an inappropriate relationship with the Rev. Sean Miller [she] caused hurt and division among the congregants of the First Presbyterian Church of Greenwich, CT."

On that same date, the Stated Clerk of PSNE electronically forwarded to the Moderator and Clerk of the PPJC this and other related documents for the purpose of scheduling a Pretrial Conference.

On November 18, 2020, the Stated Clerk of the Presbytery electronically forwarded to the Moderator and Clerk of the PPJC an *Investigative Committee Recommended Actions* document that now included the signature of the Accused dated, November 18, 2020.

After internal discussion between the Moderator and the Clerk of the PPJC, the Moderator, on November 19, 2020, forwarded the Proposed AFR to the members of the PPJC and set a date for deliberation and decision on the proposed AFR on December 8, 2020.

On December 8, 2020, the PPJC met by Zoom Web Conferencing to deliberate and issue a Consent Order for the Proposed AFR.¹

PROPOSED AFR

Investigative Committee Recommended Actions

¹ This meeting of the Presbytery Permanent Judicial Commission was not held in person due to the restrictions put in place by the various state and local authorities in response to the Novel Corona Virus.

Investigative Committee Recommended Actions

Guided by the principles of church discipline, as stated in D-1.0101, we the members of the Investigative Committee, make the following recommendations with regard to the charges brought against Elder

It is our determination that Elder is guilty of the violation of W-4.0404.g: failing to further the peace, unity, and purity of the church, contrary to Holy Scripture and the Constitution of the Presbyterian Church (U.S.A.). Her actions in pursuing an inappropriate relationship with the Rev. Sean Miller have caused hurt and division among the congregants of the First Presbyterian Church of Greenwich, CT.

Therefore, in accordance with D-12.0104, we recommend that Elder be censured and temporarily excluded from the exercise of ordered ministry and membership on church committees for a period of two years from the time this censure is delivered. We note that she has initiated and is currently undergoing professional counseling, and we make our recommendation in the hope that time away from ordered ministry and committee work will provide space and opportunity for continued self-reflection and healing.

Decision and Consent Order

The seven (7) members of the Commission (Rev. Patrick Notley, Moderator; Rev. Barbara Hager, Clerk; Elder Carolyn Blick; Rev. William Goettler; Elder Timothy McCloskey; Elder Christina McIntyre; Elder Ellen Taylor Sisson;) each issued a verbal vote on whether to approve or disapprove the Proposed AFR pursuant to Book *of Order* D-10.0202 j(3). The recorded vote is six (6) in favor of Approval; zero (0) not in favor of Approval, one (1) abstaining. Having reached a 2/3's majority of the Commission, the Proposed AFR is declared Approved.

Therefore, having reviewed the *Investigative Committee Recommended Actions* document, presented to this Commission by the Investigating Committee, and having reached a 2/3's majority of the Commission voting in favor of the *Investigative Committee Recommended Actions*, it is the Decision of this Commission that this Disciplinary Consent Order for Alternative Form of Resolution become the Consent Order for the Permanent Judicial Commission of the Presbytery of Southern New England in the Disciplinary Matter of *Presbyterian Church (U.S.A.) through the Presbytery of Southern New England v. Caroline Pandolfino*.

IT IS THEREFORE ORDERED that all recommended actions contained in this Disciplinary Consent Order for Alternative Form of Resolution be approved and enacted.

IT IS FURTHER ORDERED that the Stated Clerk of the Presbytery of Southern New England shall read this Disciplinary Consent Order in its entirety at the first stated meeting of the Presbytery following the receipt of this Disciplinary Consent Order.

IT IS FURTHER ORDERED that the Stated Clerk of the Presbytery of Southern New England shall enter the full Disciplinary Consent Order upon the minutes of the Presbytery.

IT IS FURTHER ORDERED that the Clerk of the Session of the First Presbyterian Church of Greenwich, Connecticut shall read this Disciplinary Consent Order in its entirety at the first stated meeting of the Session following the receipt of this Disciplinary Consent Order.

IT IS FURTHER ORDERED that the Clerk of the Session of the First Presbyterian Church of Greenwich, Connecticut shall enter the full Disciplinary Consent Order upon the minutes of the Session and shall send to the Stated Clerk of the Presbytery of Southern New England an excerpt from those minutes showing entry of the Disciplinary Consent Order.

Permanent Judicial Commission of the Presbytery of Southern New England

Further background: A Decision and Order in a related disciplinary matter involving the aforementioned Sean Miller was read at a special meeting of the Presbytery on April 21, 2020. At the Stated Meeting on September 19, 2020, the Stated Clerk informed the Presbytery that Mr. Miller had renounced the jurisdiction of the Presbyterian Church (U.S.A.), and that his name would be deleted from the membership roll of the Presbytery in accordance with the Book of Order.

REPORT OF THE ROUNDTABLE

While the Roundtable has not held a regular meeting, the chair, the Rev. Julie Emery, reported that the members of the Roundtable have been meeting to discuss a book they are reading, *White Too Long*, by Robert Jones.

REPORT OF THE GENERAL PRESBYTER

The Rev. Shannan Vance-Ocampo alerted the Presbytery to an e-mail scam, in which someone is impersonating Presbytery leaders and sending members of the community requests for financial

assistance.

She introduced Brian Frick, who provided an update on the Stony Point Conference Center. SPC has had to reduce its staff greatly, owing to the decline in guests during the pandemic. They have approximately 20 single-occupancy rooms which will initially be available only to private individuals.

COMMITTEE ON MINISTRY

The report of the Committee on Ministry was given by Elder Clare Schimpf, co-chair of the committee. She reported that the Committee had taken the following actions:

- 1. **APPOINTED** the Rev. Joan Priest as moderator for St. Andrew's Presbyterian Church effective December 1, 2020.
- 2. Approved the Ministry Information Form for St. Andrew's Presbyterian Church at January 13, 2021 meeting.
- 3. **APPROVED** the transfer of The Rev. Barbara Hager to the Presbytery of New Hope, if the way be clear.
- 4. Acknowledged receipt of the contract between The Rev. Susan Pfeil and the United Congregational Church, Norwalk, CT effective January 1, 2021 through June 30, 2021.
- 5. **VOTED to END** the parish associate covenant relationship between The Rev. Lynda Clements and the Session of the Dunn's Corners Presbyterian Church of Westerly, at their mutual request.

(Note: those actions taken on behalf of the Presbytery under the authority delegated to the Committee are indicated in **BOLD TYPE**.)

Ms. Schimpf noted the passing of the Rev. Dr. Jeffrey C. Wood, HR, in January, and she introduced the Chaplain to Clergy, the Rev. Jim Glenn, who offered a memorial moment.

REPORT OF THE TRUSTEES

The Rev. Anne Marie Meyerhoffer, President of the Corporation, gave the report of the Board of Trustees. At the recommendation of the Trustees, the Presbytery **VOTED** to **ADOPT** the following:

RESOLVED, the Calvary United Presbyterian Church of Fall River ("Church") located at 216 Harrison Street Fall River, MA 02723 has applied for a loan as follows from the Presbyterian Church (U.S.A.) Investment and Loan Program, Inc. ("Lender") funded by Endowment Funded

Loans: Amount of Loan: \$17,000.

FURTHER RESOLVED, the Corporation of The Presbytery of Southern New England, a Massachusetts foreign corporation, ("Presbytery") having received and reviewed the Loan application of the Church, a member in good standing of this Presbytery, approves the Loan application, and guarantees the repayment of principal and interest on the loan to the Lender as described above. The officers of the Presbytery as listed on the attached Certificate of Incumbency marked Exhibit A are authorized to sign a guarantee and any and all documents of this loan as authorized agents of the Presbytery.

Upon the recommendation of the Trustees, the Presbytery further **VOTED** to **APPROVE** the sale of the property at 87 Square Acre Drive in Stamford, CT, held by the Turn of River Church, to Mr. Richard Breglia of 33 Sound Beach Ave Ext, Riverside, CT, for the sum of \$380,000. The Board of Trustees have reviewed the contract of sale. The full proceeds and any income generated by this principal amount shall be designated for housing expenses for ministers employed by the church.

RECESS

The Presbytery observed a brief **RECESS**, and the meeting resumed at 7:30 p.m.

COMMITTEE ON PREPARATION FOR MINISTRY

The Rev. Joan Priest, co-chair of the Committee on Preparation for Ministry, presented the committee's report. Upon the recommendation of the Committee, and by the required three-fourths margin, the Presbytery **VOTED**, in accordance with *Book of Order G-2.0610* and *G-2.0607d*, to **AUTHORIZE** the Committee on Preparation for Ministry to oversee the process of ascertaining the readiness of Candidate Gerson Roca (Providence, RI: Providence Presbyterian) for ministry in two areas covered by the standard ordination examinations -the Bible Exegesis and Polity Ordination Exams—by alternative means. Candidate Gerson Roca's readiness will be determined in a series of dialogue-based examinations as well as written work.

Rationale: Gerson Roca has been in the process of seeking Ordination for 16 years. He very much wants to be ordained and serve as a minister of word and sacrament. He is a native speaker of Portuguese and taking the ordination exams in English has been a long and difficult process for him. The Bible Exegesis and Polity exams are the only requirements left before he can become CRRC. The committee would like permission to set up these dialogue-based examinations, as well as the proper written exegetical work. Please note, we are not setting a new precedence or have the intent to simply move him on. As well, the Presbytery has already affirmed his call to the ministry when they

voted him into the Candidacy Phase. He is currently working as a nurse at a hospital in MA, working closely with COVID patients and is undercare of the Providence Presbyterian Church. The CPM will be resourced through this process with the Stated Clerk, General Presbyter and the Office of Examinations in the Office of the General Assembly and report back at the May meeting of the Presbytery.

NOMINATING COMMITTEE

The Rev. Chris Tate, the chair of the Nominating Committee, presented its report. On behalf of the committee, he **PLACED IN NOMINATION** the Rev. Mark Montgomery (a Temporary Member serving as the Interim Pastor of the First Presbyterian Church of Greenwich) for election to the Task Force on Emerging Ministries. There were no nominations from the floor. The nominations were closed, and Mr. Montgomery was **ELECTED**.

ADJOURNMENT

With no further business to transact, Presbytery **ADJOURNED**, and was led in a closing prayer by the Vice Moderator, Rev. J. C. Cadwallader, at 11:45 a.m.
