**Call to Order**

The organizing meeting of the Presbytery of Southern New England (PSNE) Igreja Presbiteriana Brasileira (IPB) Administrative Commission was held on a video teleconference via the Zoom platform on March 30, 2022. The Stated Clerk of the Presbytery, Rev. David Baer, called the meeting to order at 7:00pm. Rev. Baer led the Session in an opening prayer.

**Introductions**

The meeting started with those present introducing themselves.

**Administrative Commission Purpose and Background**

The Stated Clerk and the General Presbyter then outlined the tasks the Presbytery has charged this Administrative Commission (Commission) to accomplish and the background history associated with those tasks.

General Administrative Commission Responsibilities – It was stressed the actions of this Commission are regarded as actions of the PSNE. Commission decisions will be reported at the next Presbytery meeting and can be amended or rescinded. As such, the Commission shall keep records of its proceedings and shall submit them to the PSNE Stated Clerk.

Book of Order – The *Book of Order* (G-1.02) outlines the responsibilities of the Presbytery when organizing a new congregation into Presbyterian Church (U.S.A.) membership. The Presbytery has charged the Commission to take on these organizing responsibilities.

Presbytery IPB Commission Charge – The Presbytery has voted to charge the Commission with the following responsibilities:

1. Application - Receive an application from IPB-Hyannis for membership in the Presbyterian Church (U.S.A.) to be prepared in both Portuguese and English.
2. Organization Decision - At the discretion of the Commission, declare the IPB-Hyannis an organized congregation of the Presbytery.
  - a. Identify prospective members;
  - b. With leaders of community, explore meaning of commitments; and
  - c. Upon presentation of covenant, at the discretion of the committee, recognize IPB-Hyannis as a congregation of the PSNE.

3. Session - Assume the powers of the IPB-Hyannis session until such time as a duly elected session is installed. These powers shall include:
  - a. Authority to call meetings of the congregation to elect ruling elders, and if the congregation so decides...deacons.
  - b. Authority to train, examine, ordain and install those persons elected by the congregation.
4. Miscellaneous – Work closely with the congregation to:
  - a. Pastor - Formally call installed pastoral leadership;
  - b. Plan for the service and witness of the congregation;
  - c. Provide training and resources to officers, especially with respect to polity and finance (Current Treasurer is the brother of Pastor Dacunha);
  - d. Provide training and resources to the following items are properly created:
    - i. Church Bylaws,
    - ii. Pastor’s Terms of Call that includes in part:
      1. Salary that meets Presbytery standards;
      2. Continuing education reimbursements;
      3. Mandated health, death, disability coverage and pension benefits;
      4. Vacation allowance; and
      5. Family Leave.
    - iii. Sexual Misconduct Policy,
    - iv. Child Protection Plan and
    - v. Manual of Operations
  - e. Counsel concerning incorporation and bylaws for the congregation conforming to the Constitution of the Presbyterian Church (U.S.A.);
  - f. 501(c)3 – Investigate the disposition of the 501(c)3 status previously formed by the congregation; and
  - g. Insurance – Act as a resource in the establishing insurance protection for the congregation.
5. Organization Worship Service – Conduct a service of organization in which the commission will install church officers, express thanksgiving to God on behalf of the Presbytery for the congregation’s ministry and ask for God’s blessing upon the new congregation. Invitations will be sent to the wider PSNE community and other appropriate individuals.

Organizing Pastor – The Rev. Alonso Dacunha was received by the PSNE as the organizing pastor of IPB-Hyannis in 2010 (relationship with PSNE established in 2008). Pastor Dacunha’s wife, Katia, has been very active in the congregation and in the ministries of the congregation. For example, she was visiting woman in Suffolk County Prison (not sure of the current status).

#### IPB-Hyannis Congregation

The General Presbyter provided background on the IPB-Hyannis congregation. Items mentioned included:

1. 2008 marked the beginning of the relationship of IPB with the Presbytery of Southern New England;
2. IPB carries out a “traditional” congregational ministry i.e. worship, pastoral care, Christian education, etcetera;

3. Community mission oriented
  - a. Latinx ministry for women, with the Pastor's wife providing leadership;
  - b. Serve as chaplains for ICE detention centers;
  - c. Take seriously a *Matthew 25* ministry;
4. Membership Demographics
  - a. Largely an immigrant congregation;
  - b. Many members are involved in "hospitality" work on the Cape;
  - c. There is an ESL ministry of some 60-80 persons via Zoom;
  - d. English Language - Open to establishing an English-speaking service of worship, particularly for the 2<sup>nd</sup> generation members and beyond...
5. Church Building
  - a. They were nesting in a small Church in Hyannis that abruptly *cancelled all rental contract indefinitely* during the pandemic;
  - b. Currently renting a small building owned by the Town of Yarmouth;
  - c. Eager to have their own space.

Cultural Considerations – There was discussion about the attention that must be given to the cultural differences of the IPB-Hyannis congregation. The Presbytery's anti-racism work was highlighted along with denominational resources for working with IPB-Hyannis. Resources discussed included:

1. Rev. Shannan Vance-Ocampo, PSNE General Presbyter,
2. Rev. David Baer, PSNE Stated Clerk and
3. Rev. Jenny Peek (Jennifer.peek@yale.edu) and Kirk Louis (kirkandshavon@gmail.com), Chairpersons of the Anti-racism and Equity Committee.

There was extensive discussion about providing resources translated into Portuguese. The *Book of Order*, sample policies, bylaws and manuals of operation need to be available in Portuguese so that they are assessable to the congregation. The Stated Clerk discussed the status of General Assembly Portuguese language resources:

1. *Book of Order* - There is a need for a full translation.
2. *Book of Confessions* - It's fully translated, but *not yet* available in a single volume.
3. Rules of Discipline - only the *Preamble* is currently available in translation.

Much work remains in producing these resources. The Committee needs to seek help from Presbytery other congregations and General Assembly for this assistance.

A translator will be necessary for the Commission to carry out its work.

#### **Administrative Commission Budget Question:**

The Stated Clerk and the General Presbyter was asked budget questions. What is the budget for the work of the Commission? Is there reimbursement for out-of-pocket expenses of Commission members (e.g. travel, meals together, etc.)? There was a general nod to paying for gas, but the Commission members were given no specifics. We will need to receive details on this from Presbytery.

**Election of Commission Committee Positions:**

There was discussion on who would take on the responsibilities of Administrative Commission Moderator and Administrative Commission Clerk.

General consent of the Committee was given to electing:

- Teaching Elder, Gregory Keosaian as Administrative Commission Moderator and
- Ruling Elder, Peter Cameron as Administrative Commission Clerk.

**Review of the March 30, 2022 Meeting**

The Committee spent some time reviewing the last meeting. There was a general consensus that our meetings in the future should be about an hour long.

**Budget**

The Committee considered the budget that will be needed in 2022 to do the work called upon by the Presbytery. At the last meeting, General Presbyter, Rev. Shannan Vance-Ocampo told the Committee that they should be reimbursed for things such as mileage and translation services. A Google search indicated the current IRS mileage reimbursement rate is \$0.58. The Committee identified three areas in which we might need reimbursement: mileage, translation services and meals with IPB.

MSV to submit a 2022 budget request to the Presbytery for \$1,500. The Administrative Commission Clerk agreed to communicate this request to the Presbytery's Stated Clerk.

**Cultural Differences Between the IPB, Committee & Region**

General Observations - Gerson Roca provided some generalizations about Brazilian Presbyterians with the caveat that in the end we will have to get to know the IPB

congregation and forget the generalizations. He provided the following experience for consideration:

- Many in the congregation may be very conservative theologically;
- Should there be any undocumented members of the congregation, this will affect this part of the Body of Christ. It will create an atmosphere where members search for safety, feel fear and experience lots of stress. It can also create volatility in the congregation as members leave the area.

Barnstable County Sheriff's Office – Anne Weirich informed the Committee that the Barnstable County Sheriff's Office is the only county in the Commonwealth of Massachusetts that has an arrangement with ICE that allows the sheriff deputies to round up undocumented immigrants.

Translation – As there are members of the IPB congregation that have trouble communicating in English, translation will be a necessary part of the work of this committee. Translation will be necessary when meeting with IPB and with documents that are a part of PSNE membership process.

Gerson Roca has unique gifts in translating between the Brazilian and English languages. The other three committee members made it clear to Gerson he should not feel any obligation to be a translator for the Committee. We are prepared to use outside resources to accomplish our translation tasks. Gerson made it clear he wants to use his translation gifts as a part of his committee work. He said he does the type of translation we will need often in other parts of his life. He is glad to do it.

The Committee thanked Gerson and agreed we would ask him to use his translation skills. We will need, in particular, translation of the *Book of Order* provisions having to do with the organizing covenant (G-1.0201) and the constitutional questions when ordaining Ruling Elders and Deacons (W-4.0404).

Anti-racism Resources – The General Presbyter provided the Committee with information to allow us to make use of the PSNE anti-racism consultant, Jessica Vazquez-Torres.

General consent was given to have Anne Weirich schedule a Committee Zoom session with Jessica Vazquez-Torres on April 27, 2022 at 6:00pm.

**Discussion on Meeting with Igreja Presbiteriana Brasileira of Hyannis**

Ordination Questions – It was noted Gerson has translated the constitutional questions into Portuguese.

Committee Philosophy on Process – There was a general discussion on what the critical issues were that would enable the commissioning of the congregation into the PSNE and those issues that would point to a better fit elsewhere. Some of the items discussed included:

- The need to understand jointly and severally the positions of the congregation and the leadership team.
- Polity – Understanding of PCUSA polity and acceptance of the differences that this polity allows in theology and style.
- Finances – It was agreed there needs to be a discussion about the leadership team’s thoughts on how their finances will work and the need to adopt PSNE financial practices. The committee discussed everything from how we can be problem solvers to help the congregation address financial issues to discussing those issues that create challenges.
- Cultural Differences – We discussed in several different ways the care we need to take to ensure good communication with the cultural differences between the congregation and the committee.

Question - There was general agreement that a good way to get at many of the issues we discussed was to ask the leadership team and the congregation the question:

“Why do you want to be Presbyterian?”

This question and variations of it will allow us to delve into many of the issues that must be explored.

### **Next Meeting**

By acclamation the committee agreed the Rev. Alonso Dacunha and his wife, Katia, should be invited to the next committee meeting to discuss and receive their advice on how to speak to the Igreja Presbiteriana Brasileira of Hyannis congregation. The moderator will offer an invitation both Alonso and Katia to attend the next meeting.

**Approval of the Minutes**

The Commission discussed the minutes from their May 18, 2022 meeting.

There was a motion made that was seconded and voted upon (MSV) to approve the minutes of the May 18, 2022 Commission meeting.

**Approval of the Agenda**

**Introductions**

The meeting started with introductions by all attendees. The discussion then moved to Rev. Alonso Dacunha and Ms. Katia Dacunha educating the committee on who they are and providing information on the IPB congregation. Pastor Alonso and Katia stated on numerous occasions that both they and the congregation are Presbyterians. In fact, Pastor Alonso has been a Presbyterian since his birth.

Each Commission member asked questions to both Alonso and Katia. The following bullet points are a sampling of the information provided during this Q & A time:

- The congregation has a new home in South Yarmouth, MA. They are renting space from a Baptist church.
- Currently there are two weekly services 10:00am and 7:00pm along with various Bible studies, and outreach activities.

- The congregation currently serves Portuguese speaking members (most of the congregation) and Spanish speakers. It is leadership's goal to serve English speakers in the future. They want to be bilingual. They told us they have to be bilingual if they are to serve the children of the membership.
- The Cape Cod community is aware of the IPB congregation and what they are doing on the Cape.
- Alonso has identified about 50 retired pastors living on Cape Cod and has tried to create relationships with them. There has been very limited success.
- Congregation has experienced some racial animosity.
- Financial support is important. Their members provide very good support in the summer, but outside support is necessary in the winter months. (Presbytery currently has an annual budget line item for support of the IPB congregation of \$22,000.)
- IPB is working with Gordon Conwell Theological Seminary to create an intern opportunity for a seminary student to serve at IPB.
- Both the leadership of IPB and the IPB congregation are more conservative than PSNE as a whole. Woman in leadership roles and their positions on LGBTQ individuals in their congregation were specifically discussed. There will be further discussions on these topics.

It was agreed after Alonso and Katia Dacunha left the Zoom meeting that as a next step the Commission should meet in person with them.

### **Anti-racism Training**

The committee has received the training materials from Jessica Vazquez-Torres. The next step is to set up a meeting with Jessica on her website. To this end, Anne Weirich will send Commission members a *Doodle* email so we can provide dates that we are available. Anne will use this information to schedule our next anti-racism training.

### **Next Meeting**

- Authority of the pastor;
- The priesthood of all believers...pastor, elder and congregation;
- *Book of Order*;
- The role of LGBTQ individuals in the congregation;
- The role of women in the church; and
- The meaning and practical application of baptism.

There was a discussion on how to address these issues with love and wisdom.

Ideas – The group threw out different ideas for consideration to help facilitate our conversation with the IPB congregation. Ideas mentioned included:

- Commissioning of a lay pastor;
- Using a satellite ministry; and
- Leveraging wise outside third parties

### **Next Steps**

The Rev. Vance-Ocampo will research options for help with our future communication. For example, she will look at the practicality of receiving help from the Rev. Jupiaci Carneiro ([www.millenniumchurch.org](http://www.millenniumchurch.org)).

Baptism – This is the most important issue identified to date. Pastor Alonso and the Commission must delve into this topic more deeply to fully appreciate how all parties understand this sacrament of the church. A suggestion was made that we might want to try a book study as a way of starting this conversation. The book, *Christian Doctrine, Revised Edition*, by Shirley C. Guthrie, Jr. was suggested.

IPB Leadership – Leadership from the congregation needs to be identified and nurtured in its leadership of this faith community.

English – IPB’s lack of English spoken outreach to its own church family is a critical weakness identified by this community.

Commission Onboarding – There needs to be conversations with all five Commission members present to “level set” where the Commission is at the moment.

### **Next Meeting**

It was agreed that we will invite Pastor Alonso to attend the next meeting.

**Introductions**

The newest member of the Commission, Tiffany Nicely Holleck, was welcomed. Time was spent with everyone introducing themselves.

**Background**

History - A quick synopsis of Commission's history along with the identified issues that need to be addressed was discussed. Baptism is a "bright line" issue that requires discussion with Pastor Alonso and the IPB congregation.

Gerson Roca's Conversation with Alonso – Gerson spoke with Alonso after Alonso sent the December 27, 2022 notice to the Commission. Among the items discussed was Pastor Alonso's request for an English-speaking pastor to work with the congregation.

Funding – Currently the IPB congregation is receiving \$22,000 in annual support from the PSNE. The Immigrant Ministry funding that Pastor Alonso and his wife Katia were receiving in the past is no longer available.

Early PSNE History – Anne related Rev. Ron Minor was one of the original PSNE IPB Fellowship liaisons. At the time, Ron was asked to be a companion with Alonso. Ron tried to connect with Alonso for a number of years, but found it difficult to get together with him.

Tiffany Nicely Holleck's Perspective – Tiffany was a PSNE liaison to the IPB Fellowship about 15 years ago. She feels the recap she just heard from the rest of the Commission sounds very much like where things were 15 years ago...leadership, funding and needing PSNE help. It is Tiffany's understanding that Pastor Alonso left the Orthodox Presbyterian Church in 2007.

### **Next Steps**

Agreement - The Commission agreed we should continue our work. We should be working alongside the IBP in helping them meet their goal of joining the PSNE. Pastor Alonso should not be left alone to work on this by himself.

Action Item – Communication - Commission will respond to Pastor Alonso's December 27, 2022 letter indicating it is our intention to continue the activities of the Commission based on the rationale in the above paragraph. Anne Weirich will create a first draft of the letter and send it around to the Commission for revisions. Peter Cameron will send our letter to Pastor Alonso once the letter has been finalized.

Action Item – Shannan Vance-Ocampo will meet with Pastor Alonso and share the PC(USA) Book of Order Portuguese resources. This will give them an opportunity to discuss polity, baptism etc.
