

Stated Clerk's Report
October 21, 2025

For action, from the Roundtable:

1. Roundtable recommends that Presbytery **suspend Bylaw 3.1** for 2026, to permit having only three Stated Meetings.
2. Roundtable recommends that Presbytery **amend the first sentence of Bylaw 3.1** from "There shall be four (4) stated meetings of Presbytery each year." to "There shall be at least three (3) stated meetings of Presbytery each year." This is a first reading of that change; Presbytery will vote on the amendment in February.
3. Roundtable recommends that Presbytery **approve the following calendar** for the 2026 stated meetings:
 - Tuesday, Feb 10
 - Saturday, May 9
 - Tuesday, October 27

and asks Presbytery to **authorize** Roundtable to determine location and format of those meetings.

For information:

1. We are holding a **Session Clerks' Gathering on November 15**, from 10am-1pm. The location and other information will be shared very soon.
2. The current Ministers Roll, including the 2025 Specialized/Validated Ministries Report, is attached, as approved by COM at its October meeting. Please note that there are still some updates in process from information received from the Annual Report, so several members on the At Large list will have their ministries reviewed for validation in the next couple of months.
3. If you are a retired member of Presbytery and did not complete the 2025 Annual Ministers Report this summer, please do so at your earliest convenience. We are hoping to maximize participation this year to review our records, contact information, etc. Let me know if you need a survey link.
4. The 2025 Terms of Call/Pastoral Compensation report is attached. Please note that this is typically reported at the May Stated Meeting. Even waiting until the fall, several churches have not reported, or only partially reported, this information.
5. The 2026 Compensation Worksheet will be available later this fall, after the 2026 Pastoral Compensation Policy is approved. Please plan to use the updated worksheet in reporting next year's Terms of Call/compensation information to the presbytery.
6. Overtures to the 227th General Assembly will be considered at the February meeting. Please let me know of any overtures you would like considered by late January. We might be able to handle concurrences at the May meeting but that will be past the deadline for new overtures.
